- 4. Copy of the applicant's three-year driving record, issued by the Oklahoma Department of Public Safety or Oklahoma tag agency, obtained no more than 30 days prior to application date.
- 5. Two forms of identification
 - Accepted identification: passport, work visa, Oklahoma driver's license, social security card, firearm/handgun permit issued by a state agency, fishing/hunting license, health insurance card, current student ID, state certified birth certificate, U.S. military ID, veteran's ID or government issued photo ID card.
- **6.** U.S. Lawful Presence Affidavit (new permits only) showing current citizenship status. You must be a U.S. citizen or legal alien to receive a driver's permit.
